Refugio Dominguez earned his Bachelor of Science in Civil Engineering at Cal Poly Pomona. In 1993, Refugio Dominguez became licensed as a Professional Civil Engineer.

Refugio joined Caltrans in 1989 and has worked on various units such as Traffic Operations, Construction, Hydraulics, and Design. Refugio has worked the last 28 years in the Office of Design.

Most of his professional experience has been in the Office of Design preparing plans, specifications, and estimates for various types of construction projects such as freeway widenings, bridge replacements, seismic retrofits, soundwalls, water pollution devices, and retaining walls.

Refugio have been a PECG member since the beginning of state service in 1989 and have been part of the corporate Meet and Confer Team for the last 14 years and is currently serving as the Vice President Supervisory for the Los Angeles Section. Prior to that, Refugio has held various positions in the Los Angeles Section including Director, President, Vice President Supervisory for 3 years, and Treasurer for 3 years. He has also represented PECG at Legislative Day, fund raising events, and supported the election of PECG supported candidates through phone banking and distributing material to the communities. WHY SHOULD THIS PERSON BE SELECTED?

Grish earned his Bachelor of Science in Civil Engineering and his Master of Science in Structural Engineering from University of Wyoming. After graduating with Honors in 1981, Grish moved to Los Angeles, CA and began working at Ralph M. Parsons Company as an Associate Engineer. In 1983, Grish became licensed as a Professional Civil Engineer, after which he became a Partner and Responsible Managing Officer at CALBEC, where he handled all aspects of structural engineering and construction from preliminary design to completion.

Before joining Caltrans, Grish worked as a Federal Project Officer for the Federal Emergency Management Agency after the 1994 Northridge earthquake. He was responsible for preparing and reviewing post-disaster public assistance Damage Survey Reports and giving engineering evaluations and assessments of Architectural & Engineering reports.

Grish joined Caltrans District 7 as a Project Engineer with the Office of Design in 1999. As a Project Engineer for nine years, Grish delivered over \$200 million of COS projects, such as the award-winning Long-Life Pavement Reconstruction Project along Route 710. In addition, he was recognized for his work in completing the PS&E package for the LA-5 Tunnel Repair Project within ten days of the date of notification, for which he received a Superior Accomplishment Gold Award.

For the last ten years, Grish has served as a Senior Transportation Engineer with the Office of Traffic Design. During this time, Grish has directed and supervised staff in delivering all the assigned projects on-schedule and within budget. In 2011, under the Office Chief's initiative, Grish developed the Workload Estimating Norm (WEN) to estimate office resource needs for several types of projects, for which he received another Superior Accomplishment Gold Award. On many occasions during his tenure as a Senior Transportation Engineer, Grish has been Acting Chief, Office of Traffic Design in the Division of Traffic Operations during the Office Chief's absence.

Grish has been the Chief of the Office of Traffic Design in Caltrans, District 7 since January 2018.

On the personal side, Grish has been married for 35 years. Grish and his wife have three daughters: (1) Michelle is a Deputy Attorney for Caltrans in the Los Angeles Legal Office, (2) Stephanie is an Anesthesiology Resident at LAC+USC

Medical Center, and (3) Katherine is a Commercial Product Analyst with Farmers Insurance. In his free time, Grish likes to hike, garden, and travel.
